

**INFORMATION ON THE PROCESSING OF PERSONAL DATA EX ARTICLES 13-14 REG. EU  
2016/679**

**SUBJECTS INVOLVED IN THE TREATMENT: SUBJECTS INTERESTED IN THE NEWSLETTER.**

**KT&Partners S.r.l.** as Data Controller of your personal data - in compliance with EU Reg. 2016/679 (commonly named "GDPR") - hereby informs you that the legislation in question provides for the protection of subjects involved in the treatment with respect to the processing of personal data and that this processing will be based on the fundamental principles of correctness, lawfulness, transparency and protection of your privacy and rights. Your personal data will, therefore, be processed in accordance with the legal provisions of the afore-mentioned legislation and the confidentiality obligations established therein.

**PURPOSE AND LEGAL BASIS OF PROCESSING:** Your personal data will be processed in accordance with the legislative provisions of the afore-mentioned legislation and the confidentiality obligations set out therein.

Your personal data may also, with your consent, be used for the following purposes: **sending informative and promotional communications, as well as newsletters.**

**PROCESSING METHODS:** your personal data may be processed in the following ways: with electronic computers using software systems managed or programmed directly or by third parties; entrusted to third parties for processing operations; with electronic calculators; with paper archives; data collection in public places or places open to the public; data collection by computer or telematic tools; data collection through forms, coupons and questionnaires; processing of data collected by third parties.

All processing is carried out in compliance with the methods established by Articles 6 and 32 of EU Regulation 2016/679 and through the adoption of adequate security measures.

**DATA DISCLOSURE:** your personal data will not be disclosed.

**DATA TRANSFER:** your personal data may be transferred, limited to the above-mentioned purposes, to the following States: Countries belonging to the European Union.

**DATA RETENTION/STORAGE PERIODS:** in compliance with the principles of lawfulness, purpose limitation and data minimization, pursuant to Article 5 of EU Regulation 2016/679, the retention/storage period of your personal data is established for a period of time not exceeding the completion of the services provided.

**RIGHTS OF THE INTERESTED PARTY:** the interested party has the right to obtain from the data controller the cancellation (right to be forgotten), restriction, updating, rectification, portability, objection to the processing of personal data and exercise all the rights ex Articles 15, 16, 17, 18, 19, 20, 21, 22 EU Reg. 2016/679.

## INFORMATION ON THE PROCESSING OF PERSONAL DATA EX ARTICLES 13-14 REG. EU 2016/679

The interested party has the right to obtain confirmation of the existence or not of personal data concerning him/her, even if not yet recorded, their communication in an intelligible form and the possibility of making a complaint to the Supervisory Authority.

Specifically, the interested party has the right to obtain information on: the origin of the personal data; the purposes and methods of processing; the logic applied in case of processing carried out with the aid of electronic instruments; the identification details of the data controller, data processor and managers and the representative designated pursuant to Art. 5.2. EU Reg. 2016/679; the subjects or categories of entities to whom or which the personal data may be communicated or who or which may become aware of them as designated representatives in the territory of the State, managers or agents in charge of the processing.

Furthermore, the interested party has the right to obtain: updating, rectification or, when interested, integration of data; cancellation, transformation into anonymous form or blocking of data processed unlawfully, including data whose retention is not necessary in relation to the purposes for which the data were collected or subsequently processed; certification that the operations referred to in the previous points have been brought to the attention, also with regard to their content, of those to whom the data have been communicated or disseminated, with the exception of the case in which this fulfillment proves impossible or involves a use of means manifestly disproportionate to the protected right; data portability.

Finally, the interested party has the right to object, in whole or in part: for legitimate reasons, to the processing of personal data concerning him/her, even if pertinent to the purpose of the collection; to the processing of personal data concerning him/her for the purposes of sending advertising material or direct sales or for carrying out market research or commercial communication.
